APPENDIX A—DISMISSAL CHARTS

NOTE REGARDING EVENTS GOVERNED BY FRBP 9014: Though the rule might be read by some to suggest the filer must serve the motion to dismiss upon all parties in interest, the ultimate relief sought is covered by the hearing notice the Court will serve on all parties in interest for most events. As noted in the "Court Action" column below, other rules specifically permit limited notice for certain events. Accordingly, the charts below do not indicate service of any motion to dismiss on all parties in interest and references to FRBP 9014 in the "Docket and Serve" column only appear when the "debtor" is the party against whom relief is sought or, in the Chapter 7 context, when the debtor seeks dismissal and there are postpetition creditors.
